

Saludos Friend,

Republicans are at it again! Mirroring SB 202's introduction last year, they rapidly introduced and passed out of committee HB 1464- an anti-voting omnibus bill. The bill adds additional procedural layers to an already burdened election administration process. Provisions include new restrictions on the number of voting machines on election day, new thresholds for handling absentee ballots, the enabling of unlimited ballot challenges by third parties, and the limiting of funding and donations of food and water to election administrators. Among the most chilling effects of the new legislation are the provisions that would allow the Georgia Bureau of Investigations to have a role in election review. There is a strong chance this bill will get a full floor vote and crossover into the Georgia Senate before Crossover Day, March 15 - with a possible floor vote Monday or Tuesday.

Our coalition members are moving fast to counter this bill! Please call Speaker David Ralston (404-656-5020), and Rules Chair Richard Smith (404-656-5141) NOW to demand they stop this bill!

As a reminder, we are very close to the end of the legislative session, with crossover day next week on March 15th and Sine Die on April 4th!

Crossover Day: Bills must pass out of either legislative chamber to be viable for the current session. Bills that fail to do so are no longer considered during the current session.

Sine Die: This is the term used for the last day of the legislative session. Bills must pass both legislative chambers before being sent to the Governor for signature before the "end of day" on the 40th day.

Please remember that our <u>legislative priorities for the year</u> are advancing voting, immigrant rights, environmental justice, and championing the inclusion of immigrant provisions in the Build Back Better Plan.

**Voting Rights & Administration Bills** 

SB 325 (Dropbox Ban) | This bill would ban the use of absentee ballot drop boxes statewide. Status: The Senate has read and referred this bill to the Senate Ethics Committee.

**HB 933**: This bill would remove provisions that keep ballots and documents under seal. **Status:** House Second Readers - Assigned to House Committee on Governmental Affairs.

**HB 886**: This bill addresses chain of custody and ballot requirements. Leads to concern about the burdens and costs that counties may incur. Status: House Committee favorably reported by substitute.

**SB 350**: Procedure updates for Nonpartisan General Elections, including when nonpartisan elections can be held. Status: Senate read and referred - Senate Ethics Committee.

**SB 442**: Would allow for voters to choose to permanently receive absentee ballots. Status: Senate read and referred - Senate Ethics Committee.

**SB 443**: This bill would remove the prohibition regarding providing food and drink to people in line to vote at polling places. Status: Senate read and referred - Senate Ethics

Committee.

**SB 444**: This bill would remove any limitation on the number of absentee ballot drop boxes that can be used for elections. Status: Senate read and referred - Senate Ethics Committee. HB 975: This bill would allow for the creation of a board of

elections and the selection and appointment of members to take the place of the judge of the probate court. Status: House Second Readers - House Committee on Government Affairs.

HB 1085: Would create an option for municipalities to adopt and use instate runoff voting. Status: House committee favorably reported - House Committee on Government Affairs.

HB 333: Would revise the powers and duties of the Georgia Government and Transparency and Finance Commission as well as procedures, contribution limits, etc. Status: Recommitted to Senate Rules Committee.

**HB 1359**: Would make elections administration harder. Status: House Second Readers - House Special Committee on Election Integrity.

SR 363 (Non-citizen Voting Ban) | This resolution would make the state's ban on voting by noncitizens part of the state constitution. Status: FAILED IN THE SENATE!

K-12/Higher Education Bills

HB 932 (In-state Tuition) | This bill would allow non-citizen refugees to utilize in-state pricing for college tuition. Status: House Second Readers - House Higher Education Committee.

HB 888: This is a classroom censorship bill that would ban conversations of race and racism in the classroom and other conversations/engagements around public policy. 20% of annual funds will be cut if these terms are violated. Status: House Second Readers - House Education Committee.

#### **Immigration Bills** SB 448: This bill would allow officers (without warrants) to

check one's citizenship status during traffic stops. **Status:** This bill is assigned to the Senate Judiciary Committee.

**Redistricting Bills** 

Status: Passed both House and Senate. Signed into law. HB 872: This bill revises the district boundaries for the
